Please note: The \$50 Advancement to Candidacy fee will be included as part of fee remission if assessed in a quarter in which the student qualifies for fee remission.

Please note: Non-Resident doctoral students who have advanced to candidacy receive a Non-Resident Supplemental Tuition reduction of \$5,034 for a maximum of 9 quarters.

Please note: For students who are eligible for IDRF, a Non-Resident Supplemental Tuition credit of \$5,034 will be paid via fellowship.

Notes

With respect to Partial Fee Remission for TAs, Associates, Readers, Tutors/Remedial Tutors, and GSRs at appointments of at least 25%, the current Collective Bargaining Agreement stipulates that the University shall provide a **Partial Fee Remission of 100% of tuition, student service fee, and campus-based fees, which consist of GSA fees and Student lock-in fees and remission of the premium for the University-sponsored student health insurance plan (UCShip)**. The remissions quoted above are consistent with the terms of the current contract, and current levels of fee remission are in effect at the time of its publishing. Please be aware that future wages, terms, and conditions are subject to modification based on the collective bargaining process.

Graduate Student Fee Remission applies Fall, Winter and Spring Quarters to eligible registered graduate student academic appointees. GSRs whose appointments total at least 25% but less than 35% and meet all other criteria are eligible for Partial Fee Remission and University of California Student Health Insurance Plan (UC SHIP) credit. GSRs who are appointed at least 35% and meet all other criteria qualify for a Full Fee Remission and UC SHIP credit.

UC Student Health Insurance: Health insurance is mandatory. Graduate students may have the UC SHIP fee waived by proving to Student Health Service that they have comparable coverage under another health insurance policy.
